CIRCULAR

Sub: Requirement of "COVID-19 Test Certificate" for passengers to Travel Abroad.

- 1. Reference is made to Civil Aviation Authority of Bangladesh Circular no. 30.31.0000.112.42. 001.20-3150, dated 18 July 2020 and the decision of the inter-ministerial meeting held on 21 July 2020 on the above mentioned subject.
- 2. As per the decision of the inter-ministerial meeting, in addition to the requirments laid down in the CAAB Circular referred above, with effect from 26 July 2020, all foreign passport holders intending to depart for any international destination from any of the airports of Bangladesh shall have to obtain "COVID-19 Test Certificate" except the followings:
 - (a) Diplomats, members of UN organizations and sister organization of UN, Head of International organizations and their family members; and
 - (b) Foreign Investors and foreign passport holders who stayed in Bangladesh for less than 14 days.
- 3. In addition, "COVID-19 Test Certificate" is not mandatory for children below the age of 10.
