Subject: Imposition of Value Added Tax (VAT) on Aeronautical and Non-Aeronautical Charges.

This is to inform you that as per section 3 of the Value Added Tax (VAT) Act 1991, the office of the Customs, Excise & VAT Commissionarate has imposed VAT on the following Aeronautical & Non-Aeronautical Charges from the Fiscal Year 2009-2010.

Sl. No.	Sectors	Rate
1.	Landing Charge	15%
2.	Route Navigation Charge	15%
3.	Security Charge	15%
4.	Boarding Bridge Charge	15%
5.	Embarkation Fee	15%
6.	Licence Fee	15%

It may be noted that at present CAAB is collecting/deducting VAT from the bill of Non-Aeronautical Charges and VAT is not being collected/deducted from Aeronautical Charges. CAAB requested National Board of Revenue (NBR) vide Letters No. CAAB/A-A/Estate/IL-338/collection-1)/55/5949, Dated: 11.02.2015 & No. CAAB/Central Accounts/fee/deducation of VAT/2938, Dated: 04.06.2015 for not to impose/charge VAT on Aeronautical Charges. But NBR has regretted the appeal and informed CAAB, vide Letter No.08.01.0000.068.25.005.15/144(1), Dated: 22.03.2015.

In view of the above, all concerned Airlines/Organizations are requested to pay 15% VAT on Aeronautical and Non-Aeronautical Charges from 01 July 2015 and deposit the arrears amount of VAT from the FY 2009-2010. VAT on Embarkation Fee is to be paid on tickets issued on/from 01 August 2015 only.
